#### "Tell your MP and Bell that prisoners need access to free phones!

"In many federal prisons across Canada...prisoners can only dial-out by making

collect calls to landlines. There are no free calls, and calls can cost over a dollar per minute. Marginalized families and community members - including parents, women and children - bear the financial burden of incarceration and often cannot pay the price to keep in touch with loved ones in prison. "The high cost of prison phone calls also affects lawyers, health care providers, and community agencies who support prisoners upon release. Most prisoners re-enter the community, but reintegration is at risk when they cannot access social support, housing, and employment." "#JusticeForKyaw Petition: demand justice for RCMP murder of Kyaw Din" "Kyaw Din was murdered by Ridge Meadows RCMP officers on August 11th.

"Officers attended Kyaw Din's home after his sister, Yin Yin, called the police for assistance taking him to the hospital. Although Kyaw was calm and non-violent, RCMP officers insisted on confronting him, rather than heeding Yin Yin's multiple requests that they wait for her older siblings. Without even communicating to Kyaw, who spoke little English, two police officers were outside his bedroom door, opened it with a taser drawn, and then, within seconds, shot him three times in the face, neck, and chest." "When the police show up to confront people who are in mental distress or using drugs, they put those people's lives at risk."

"On January 15 2020, multiple police officers inside a Halifax, Nova Scotia Walmart assaulted Santina Rao in front of her two children after accusing her of stealing groceries. When police and Walmart staff confronted Santina, and she offered that they search her belongings, police shifted tactics and asked for Rao's identification.

"Multiple officers ultimately attacked Santina, broke her wrist, and left her with a concussion and bruises all over her body. The police then laid three criminal charges on Santina, saying she assaulted the police, resisted arrest, and created a disturbance..."

She is in a cell with very little socialization or freedom to roam and has undergone a tremendous amount of pain and trauma recently... People from various groups "gained entry to the site" of a **future immigration prison in Surrey**\* October 3 after "CBSA/construction workers left the door open" and they "found that CBSA training at this facility is already underway." The people came from No One Is Illegal, Anti-Police Power Surrey, and Vancouver Prison Justice Groups/Joint Effort and "gathered in **solidarity with actions across Canada, called for by Solidarité sans frontière**". \*Surrey "occupies the unceded traditional territories of the Kwantlen, Musqueam, Katzie, Semiahmoo, Tsawwassen, Qayqayt and Kwikwetlem peoples." Canada Border Services Agency (CBSA) newly requires its officers - when with immigrants in detention - wear "steel-toed boots," "soft body armour," and carry "a defensive baton, pepper spray and handcuffs." This is opposed by the United Nations and many doctors, lawyers, and human rights groups in Canada. Thousands of people gathered at Main and Hastings February 14 for the 29th Annual **Women's Memorial March** "to **honour the lives of missing and murdered women and all women's lives lost in the Downtown Eastside** [DTES]. Increasing deaths of many vulnerable women from the DTES still leaves family, friends, loved ones, and community members with an overwhelming sense of grief and loss. Indigenous women disproportionately continue to go missing or be murdered with minimal to no action to address these tragedies or the systemic nature of gendered violence, poverty, racism, or colonialism."

"This event is organized and lead by women in the DTES because women — especially Indigenous women — face physical, mental, emotional and spiritual violence on a daily basis. The February 14th Women's Memorial March is an opportunity to come together to grieve the loss of our beloved sisters, remember the women who are still missing, and to dedicate ourselves to justice." https://womensmemorialmarch.wordpress.com https://facebook.com/groups/womensmemorialmarch

Organizing by friends, family, and groups like PASAN succeeded in winning **Moka Dawkins'** release from prison around Nov 10 who "was arrested in 2015 for defending herself from violence and as a Black, trans-sex worker" - Moka has since already spoken at Trans Day Of Remembrance events in Toronto at the Freedom School and the 519 community centre. http://pasan.org https://freedomschooltoronto.ca https://facebook.com/justiceformoka

**Secwepemc** land defender Kanahus Manuel and Isha Jules were arrested October 19 after they "stopped to tell construction workers they had no Secwepemc consent" and during which a police officer broke Manuel's wrist. "Manuel and Jules were staying nearby at a camp they built with the **Tiny House Warriors** to protect a river crossing from the proposed Trans Mountain pipeline." https://facebook.com/tinyhousewarriors twitter.com/KanahusFreedom

In Ottawa on the 10th of June, 20 **land protectors and allies were arrested before they could petition** the Environment Minister's office against the poisonous effects of the Muskrat Falls dam. To prevent the poisoning of the reservoir of the **Muskrat Falls** dam in **Inuit** territory (Labrador, Newfoundland) a 2011 federal-provincial study found its area "must be cleared of all trees, brush, foliage and topsoil" but one of the people arrested, Nunatsiavummiuk woman Amy Norman from Happy Valley-Goose Bay, said that prevention is not being considered. https://theguardian.pe.ca/news/provincial/inuit-land-protectors-arrested-on-parliament-hill-320779 https://facebook.com/OntarioMuskrat

Prisoners began a **work and hunger strike at Clallam Bay prison in Washington** state last October for demands beginning with "healthy, sustainable food". Within days, 37 "cultural leaders of groups inside Clallam Bay Corrections Center have been shipped off to Walla Walla and Coyote Ridge Corrections without any of their belongings and put into solitary confinement. They are targeted as advocates of social justice organizing that has been happening in Clallam Bay over the years". October 15 Abolish Cages: Birds of the Concrete Jungle began a **campaign to end solitary confinement** in Washington state, release the 37 targeted prisoners from solitary and "begin a productive dialogue" with "Prison Population Representatives". By November 19 **five prisoners filed a lawsuit** because the Department of Corrections "violated their rights to due process, equal protection of the laws and constitutional guarantee against cruel punishment." peninsuladailynews.com/crime/officialclallam-bay-corrections-center-fight-racially-motivated

Public pressure in late 2018 resulted in the **Canada Pension Plan** Investment Board **selling all its shares** by March 2019 **in two companies that profit from migrant detention camps** in the United States. Various people opposed to this signed petitions, wrote letters, and spoke in person at CPP Investment Board hearings across Canada including people in our Prison Justice Network. https://thetyee.ca/News/2019/07/08/CPP-Sells-Shares-US-Prison-Companies

"The End Immigration Detention Network was an intervener in the *Canada v. Chhina* case that was successful May 10, 2019. This landmark decision won recognition of *habeas corpus* rights of migrants in detention across the country. This means that the **onus is on the provincial and federal governments to justify their detention of migrants**, and not on migrants to prove why they shouldn't be detained without trial or charge." http://toronto.nooneisillegal.org

People rallied in **opposition to the new \$242million youth jail in Seattle** February 18 at its official opening after "organizations fought a seven-year battle to stop the construction of the jail, arguing that the county should stop investing in a harmful, failed strategy that produces poor outcomes for youth health, education, and employment. The No New Youth Jail Coalition continues to assert that the jail needs to be shut down if the county wants to stop disproportionately harming Black, Brown, Native and low-income youth." "A jail is a jail no matter how many times the county calls it [Children and Family Justice Center] 'Therapeutic™'



slaps paint and murals on it. "We know what it is and ... we will tear down those cells and repurpose that building to truly serve our communities most impacted by systems of oppression"

Participant LeKecia Farmer wrote: "One of the earliest memories I have is of my brother, my twin, and I playing a game he made up where he would have a toy and in order to get it, Le'ecia and I would have to run to one side of the room and back to him... He is magical and I love him.

"The second memory I have of him is visiting him in juvenile detention. I remember he was trying to crack jokes with us to lighten the fact that he was in a jumpsuit, but it wasn't working. I was scared for him and our family. My sister and I got chicken pox from that horrific place and gave it to our whole kindergarten class.

"The last memory I have of him is when he called when our dad died. I hadn't seen him in years. Institutions ripped us apart and the rest of society threw him to the side. Our family felt broken and to this day is not whole."

"When I toured the [new] facility where the only fresh air was the tiniest courtyard...and tall/barren walls reminiscent of that on the border, I thought how the life is sucked out of you."

"I donned on a jumpsuit because I am angry, I am sad, I am hurt, and I never want a family to experience this. And at this moment I thought how I wish I was a toddler again: I would tell my brother that he was my friend, not an enemy of the state. I would tell him that he is loved when school officials and detention centers did not. People with New York Release Aging People in Prison (RAPP) press the state gov't to grant parole hearings to **prisoners 55 years or older** with 15 or more years served, towards the goal of everybody's freedom: "**Bring Them All Home**". In January 500+ supporters rallied in the NY state capitol. Last year, "as a result of our advocacy efforts, the decision over who may serve as a parole commissioner is now a

Prisoners in Hong Kong have been forced since January 5 to work 63% more hours in unpaid overtime to produce at least 55% more facemasks due to the novel coronavirus, under threat of punishments like meals in isolation, "more arduous" work, and solitary confinement. Guards "deliberately single out female inmates", especially aged 40 and older, as well as those "who do not speak Cantonese or English fluently", for forced night-shifts (8pm to 6am) when they "experience symptoms of overwork like blurred vision and shaking hands" during which they are forced to continue work. Like in Canada, feminized work such as with clothes is paid less than masculinized work (facemask workers in Hong Kong prisons are paid -the equivalent of a few Cdn cents per hour- 30-50% less than the highest prison wage), so for those "reassigned to facemask production, this means a coercive reduction of wages." After work, "the women would come back to their bunks and start crying." In addition, prisoners produce facemasks in unhygienic conditions including "insufficient disinfectants", impossibility of frequent hand-washing, forced reuse of facemasks after exposure to sneezes and coughs, and inability to put toilet seats down. https://lausan.hk



Over 400 out of around 4,000 **prisoners** took **strike action at Santa Rita Jail** in Dublin, California -one of the largest jails in the US, 80%+ held without sentence- October 30-November 3 "to protest widespread institutional neglect and abuse, including unsanitary living conditions, price gouging, poor medical care, forced labor, and lack of access to legal resources."

Their October 29 strike statement, which stated 26 demands, said "Santa Rita needs to evolve its systems and methods away from this punitive justice system and demoralizing, inhumane treatment of citizens and drug addicts

to a modernized system and methods of restorative justice! The current system does not make our communities any safer! To the contrary, it makes them less secure! We need to build people up, make them productive and restore their health and vitality."

The strike began after one person died in custody October 26 when people who called for help were moved "so that there would be no witnesses" and guards addressed the person in distress only after 30 minutes and when he had stopped breathing. His was the 9th death that year and the 43rd since 2014 (excluding those who died in hospital).

The hunger- and work-strike was especially disruptive because "Santa Rita depends on unpaid labor from inmates to produce 16,000 meals a day for its own operations, as well as for other jails across the Bay Area." Many prisoners work for the private company Aramark although their conditions violate California laws by not paying them wages comparable to workers 'outside' and by "assigning women prisoners fewer and less desirable hours to work based on gender."

In addition to organizing multiple phone zaps in support of the strike, Oakland Incarcerated Workers Organizing Committee communicated messages of support to the prisoners and began meeting prisoners upon their release: "To the strikers, the minute we got the word you all were in motion, we also got on the move. Media, phone calls, boosting our support outside for releases (Yeah, we're those 'pizza people' you might have heard about, waiting outside with rides, smokes, and food for releases late into the night) Santa Rita is a grimy, dehumanizing beast and half of us have been locked up in that hellhole, some for a weekend, some for years. No more suffering this abuse in silence and shame!"

The strike resulted in aggressive punishments and two related lawsuits. The November 11 lawsuit "denounces inhumane and unsanitary jail conditions, price gouging, and neglect by the jail's health provider" including exposure to biohazardous laundry from the coroner's office with no protective clothing and the November 20 lawsuit violates prisoners' and immigrant detainees' constitutional right by "providing uncompensated labor in violation of state and federal law" and under threat of additional jail time or solitary confinement. The complaint confirms that the Sheriff's deputies threatened to terminate prisoners' employment if they are sick or injured, and that many prisoners were also threatened with 30 days additional jail time if they participated in the strike.

January 20, at least 16 prisoners in **Raleigh, North Carolina** Central Prison went on **hunger strike against the torture of 200 prisoners** in the mental health unit (inadequate medical, punishments of "throwing their personal belongings all around the cell" and spraying cells with chemical mace when they attend group therapy, and barring money from those not "approved visitors" that "only engenders robbery and violence"). https://incarceratedworkers.org

By March 2, one prisoner -in solitary "going on 3 years now"- thanked supporters for their "critical" phone zap.: "y'all's action got a lot done! They released five prisoners from solitary confinement... Three prisoners they've been holding back here they have approved for the TDU program (which is a good program that is very difficult to get into)... "The excessive use of mace has ceased! ... "They removed the doctor...and replaced him with one who... "... has seen more of us this past week than the other doctor did the whole time here. Self-meds have been delivered." "I'm here, I'm alive, I'm struggling. All power to the people." itsgoingdown.org/north-carolina-prisoners-report-back-on-impact-of-phone-zap-campaign

The NC gov't is also pressed to **investigate Aero Contractors for conspiracy and corruption for transporting at least 49 people "disappeared" and tortured** by the Central Intelligence Agency 2001-'09, incl. "a 16-year-old student and a pregnant woman". Eight people disappeared 10+ years before were still missing when the report was published in 2019 and after this "the State of North Carolina has made several grants to the county airport, at least one of which was specifically used to fortify the perimeter of only Aero's corner of the facility." Following **prisoners' hunger strikes in Alabama** and support demos at Limestone Prison Jun 22 and at the Department of Justice in DC Sep 20 and Oct 1 (photo), demands focused on meeting the Alabama Department of Corrections (ADOC) with "two incarcerated individuals with their counsel" to "focus on the ongoing pattern of retaliation against those who are incarcerated and peacefully working to expose the corruption within the ADOC." Retaliations include "the ordering of continuous transfers, trumped up disciplinaries, the use of solitary confinement, the fabricated listing and validation of 'enemies,' and the planting of false rumors among inmates in order to provoke physical and potentially fatal

altercations." And "absent any response or action to this request...demand the removal of Commissioner Dunn, his deputy and associate commissioners, and Cheryl Price."
